RENTAL AGREEMENT**

THIS AGREEMENT is made(date) _____, 2017, between Shooting Starz and (your name) _____, hereafter designated the Lessee(s).

Shooting Starz does hereby rent unto the said Lessee(s) resources at the indoor gymnastics facilities situated at 250/260 Johnson Street, Wilkes-Barre, PA 18702

Upon the following terms and conditions:

1. **Term:** (Resource) Shooting Starz is leased from _____AM/PM to _____ AM/PM 2015
2. **Rent:** The Lessee shall pay rent in the amount of \$ _____ which includes tax. A non-refundable deposit of **\$50 is required.**
3. **Use of Premises:**

- Lessee shall not use said premises or any part thereof for any illegal purpose.
- Lessee agrees to conform to municipal, county and state codes, statutes, ordinances and regulations concerning the use and occupation of said premises.
- Lessee shall not bring in any alcohol from outside the facility.
- Lessee shall take reasonable care of the rented facilities.

4. Shooting Starz Obligations:

Maintain all structural components in good repair;

- Keep common areas reasonably clean and safe from defects increasing the hazards of fire or accident
- Provide gym, and/or party room in ready to play/use condition
- Party planner and equipment

5. Additional Terms: If any, attached hereto or on the reverse side hereof, are made a part of this Agreement by reference and are described as follows.

The Lessee shall defend, indemnify, and hold Shooting Starz, its officers, employees, and agents harmless from and against any and all liability, loss, expense, including reasonable attorney's fees, or claims for injury or damages arising out of the performance of this Agreement but only in proportion to and to the extent such liability, loss, expense, attorney's fees, or claims for injury or damages are caused by or result from the negligent or intentional acts or omissions of Shooting Starz, its officers, agents or employees.

The Lessee understands that injuries as a result of gymnastics and other activities are the full responsibility of the Lessee and are not covered in any way by Shooting Starz.

In signing this Agreement, the Lessee accepts all responsibility for damage, harm, or injury that may occur to the Lessee or one invited onto the premises by the Lessee and that Shooting Starz shall have no liability for such harm, damage, or injury.

6. Lessee's Obligations:
